Dear Chairmen Frelinghuysen and Cochran and Ranking Members Lowey and Leahy:

On behalf of the associations listed below, representing college leaders, educators and professionals, we write regarding the allocation you will provide for the Labor-HHS-Education and Related Agencies appropriations bill for Fiscal Year 2018 (FY18).

As you determine how best to allocate the funding under your committees' discretion, we write to ask that you maintain Congress's historic commitment to student financial aid and medical research. The recent agreement to raise the overall funding caps for FY18 and FY19 provides your committees with the ability to address longstanding needs in these areas by increasing appropriations for programs such as Pell Grants and agencies such as the National Institutes of Health. To meet the identified needs these programs have, it is important that the Labor-HHS-Education and Related Agencies subcommittee be provided the largest possible allocation.

The importance of these areas was recognized by Congress in the Bipartisan Budget Act, which provided funding specifically targeted to the NIH and for college affordability. This additional funding speaks to Congress' long-standing recognition that these are among the most prudent investments the federal government makes. Federal support for greater postsecondary attainment and for medical research results in a stronger economy and a better standard of living.

By providing a strong allocation for the FY18 Labor-HHS-Education and Related Agencies appropriations bill, you will ensure that students will continue to be afforded the opportunity
