Dear Speaker Ryan, Leader Pelosi, Leader McConnell, and Leader Schumer:

As Congress resumes its work on the FY18 budget and appropriations, I write on behalf of the Association of American Universities, an association of 60 leading public and private research universities in the United States, to urge you to reach a bipartisan budget agreement to raise the FY18 defense and non-defense discretionary spending caps and complete FY18 appropriations this fall.

A bipartisan budget agreement is important to bolstering the unique partnership the federal government forged with American research universities. This partnership has fostered unprecedented scientific achievement and economic growth since World War II and generated untold job growth, improved our national health and wellbeing, and strengthened our national security.

Congress took steps in FY16 and FY17 to reinvest in research and higher education programs after several years of sequestration cuts and declining investment. We strongly urge you to continue this momentum and reach a bipartisan agreement that allows for robust investments in research and higher education programs critical to our nation's security and prosperity, including: Pell Grants and other federal student aid programs; the National Institutes of Health; the National Science Foundation; the Department of Energy's Office of Science and Advanced Research Projects Agency-Energy (ARPA-E); the Department of Defense 6.1 basic research and other Science and Technology programs; NASA; the USDA's Agriculture and Food Research Initiative; the National Endowment for the Humanities; the Department of Education's Institute for Education Sciences; and Title VI International Education programs.

Now is not the time to turn our backs on what has helped make our nation the greatest and most advanced economy in the world. We stand ready to work with you

in support of bipartisan budget decisions that sustain this extraordinary partnership and strengthen our nation.

Thank you for considering our views.
